

ANNUAL COMPLIANCE REPORT FOR LEGAL SECTOR MEASURED ENTITIES THAT ARE ATTORNEYS (LAW FIRMS) – FOR LARGE ENTITIES ONLY

INTRODUCTION

1. The Broad-Based Black Economic Empowerment Legal Sector Code of Good Practice (LSC) was gazetted on 20 September 2024 by the Minister of Trade, Industry and Competition (the Minister). The Legal Sector Charter Council (the Charter Council) was established in terms of Paragraph 13.1 of the LSC. Paragraph 13.7 of the LSC sets out the functions of the Charter, one of which is to monitor compliance with the LSC.
2. In terms of Paragraph 13.8 of the LSC, all Legal Sector Measured Entities that are Attorneys (Law Firms) must file an annual compliance report unless they are exempt by virtue of being an Exempt Legal Entity (ELE) or a Black-Owned Qualifying Small Enterprise (QSE), in which case, they are only required to file a sworn affidavit or a certificate issued by the Companies and Intellectual Property Commission (CIPC) except in the event that they elect to obtain enhanced recognition in terms of LSC 000 in the case of ELEs.
3. The Annual Report required in terms of Paragraph 13.8 must contain the information set out below and be set out in the format as described below.
4. Please refer to pages 7 to 17 of the LSC for concepts and definitions.
5. Any reference to expenditure or other indicators shall be for the relevant Measurement Period.
6. The Annual Report must be accompanied by a B-BBEE Verification Certificate audited by an accredited verification agency, in terms of paragraph 13.8 of the LSC.
